I am pleased to announce the 2014 Commonwealth allocation of **GENERAL MUNICIPAL PENSION SYSTEM STATE AID** in the amount of \$3,225,942.44 is scheduled to be **direct deposited on September 30, 2014.**

This amount is calculated and issued in accordance with the Municipal Pension Plan Funding and Recovery Act (Act 205 of 1984). State Law prohibits use of these funds for any purpose other than to defray your municipality's police, paid firefighters and non-uniformed pension costs.

Act 205 requires that the enclosed check be deposited in the pension plan(s) by the treasurer of your municipality within 30 days of receipt.

Your allocation of state aid has been computed using data from actuarial studies that your municipality submitted to the Public Employees Retirement Commission and from the pension certification Form AG-385 that your municipality submitted to this department. The data included the number of full-time employees and the operating costs of your pension plan(s).
