- THIS APPLICATION MUST BE ACCOMPANIED BY A CHECK OR MONEY ORDER (NON-REFUNDABLE PAYABLE TO THE "CITY OF BETHLEHEM" IN THE AMOUNT OF **SEVENTY FIVE DOLLARS (\$75.00)**
- APPLICANT MUST RESIDE ON BLOCK BEING CLOSED. NO VEHICULAR ACCESS IN OR OUT OF THE CLOSED AREA. VEHICLES MAY NOT BE PARKED INSIDE THE CLOSED AREA. 15' MINIMUM CLEARANCE (CLEAR SPACE) AT ALL TIMES. MUST PROVIDE A SKETCH PLAN TO BE ATTACHED TO THE APPLICATION.
- IF EVENT BLOCKS AN INTERSECTING "T" STREET, SUBMIT A SEPARATE APPLICATION AND PETITION FOR EACH AFFECTED STREET.
- NO GRILLS, OPEN BURNS IN THE PUBLIC RIGHT OF WAY (UNLESS YOU HAVE A SEPARATE PERMIT FROM FIRE) SEE FIRE APPENDEX.
- APPLICATIONS WILL BE RETURNED IF NOT COMPLETE OR IF RECEIVED LESS THAN THIRTY (30) DAYS PRIOR TO THE EVENT
- ANY TENTS SHALL COMPLY WITH THE UCC CODE, NO TENTS TO BE STAKED INTO THE CITY STREET(S), NO ALCOHOL IS PERMITTED IN THE STREET RIGHT OF WAY.
- ALL PERMITS WILL BE VALID FROM **10:00 AM TO DUSK**, CLEAN UP PLAN ATTACHED, MUST PROVIDE A SKETCH IF ITEMS WILL BE PLACED IN THE STREET.
- NO MORE THAN TWO BLOCK PARTIES PER YEAR WITHIN THE SAME BLOCK OR WITHIN A 500 FOOT AREA

WHEN APPROVED, A BLOCK PARTY PERMIT SHALL BE ISSUED AUTHORIZING THE APPLICANT TO CLOSE THE STREET. IT IS SUBJECT TO REVOCATION IF THE APPLICANT DOES NOT COMPLY WITH ALL PERTINENT LAWS, RULES AND REGULATIONS INCLUDING ANY CONDITIONS OR RESTRICTIONS IMPOSED BY THE CITY OF BETHLEHEM.
