WHEREAS, the parties entered into a Use Permit Agreement dated April 29, 2019, pursuant to which the City granted a Use Permit to the Permittee for the use of Nevin Place (adjacent to the Sun Inn Courtyard) for the purpose of Tunes at Twilight and for the duration described therein; and

2. Section A, Paragraph.1, Event Date and Times, Subparagraph A is hereby amended to include the following additional event dates and times:

August 22, 2019 and August 29, 2019 from 5:30 p.m. to 8:00 p.m.

3. All other terms and conditions contained in the original Use Permit Agreement shall remain in full force and effect.
