2022 Draft CDBG and HOME Annual Action Plan Public Review and Comment Period

Notice is hereby provided that the City of Bethlehem, PA ("City") has completed its first draft of the 2022 Annual Action Plan for the Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) program funds.

Interested citizens are invited to examine this report and comment on its contents during the required thirty (30) day Public Review and Comment Period that will begin on Thursday, June 16, 2022 and extend through Saturday, July 16, 2022. The draft plan is available to the public for review in person during the Public Review and Comment Period at the following locations:

The public is also invited to participate in a public hearing on the draft 2022 Annual Action Plan. The public hearing will be an in-person meeting at the City Council Meeting on Tuesday, July 5, 2022, at 7:00 p.m. in Town Hall Rotunda, 10 East Church Street, Bethlehem, PA 18018. The City strongly encourages Bethlehem residents, including, particularly, low- to moderate-income individuals and families, to provide comments to the Annual Action Plan and participate in the July 5, 2022 public hearing. Additionally, the City strongly encourages local organizations and nonprofits serving low- to moderate-income individuals and families located in the City to provide comments to the draft Annual Action Plan and to participate in the above July 5, 2022 public hearing at 7:00 p.m. in City Council.

This notice is issued in accordance with the CDBG and HOME regulations. The City of Bethlehem does not discriminate based on disability.
