## Notice of CDBG/HOME Public Hearings 2025 Annual Action Plan Five Year Consolidated Plan

Notice is hereby provided that public hearing number 1 on the City of Bethlehem ("City") 2025 Annual Action Plan/ five-year consolidated plan (the "Plan") will be held on **Tuesday, June 3, 2025**, at 12:00 PM, in the Town Hall Rotunda, located at 10 East Church Street, Bethlehem, PA 18018. This hearing will concern general program and community matters. A second hearing, in City Council, Town Hall Rotunda, at 7:00 PM on **Tuesday**, **July 1, 2025**, will consider the proposed projects and allocations.

The City is preparing the Plan as part of its application for certain funding to the U.S. Department of Housing and Urban Development (HUD). The City's Community Development Block Grant (CDBG) allocation for Program Year (PY) 2025 is \$ 1,418,306.00 and the City's Home Investment Partnership Programs (HOME) allocation is \$ 417,183.96. CDBG Funds may be used to assist persons with low to moderate incomes, remove slums and blight, or address urgent needs. HOME funds may be used for homeowner rehabilitation, homebuyer activities, financing the acquisition and/or rehabilitation or new construction of homes for homebuyers or rental housing, and providing tenant-based rental assistance.

**The draft Plan is not yet available for public review.** The draft Plan will be available during the public comment period, anticipated to run from Friday, June 6, 2025, through Sunday, July 6, 2025 ("Comment Period"), at the following locations:
