ORDINANCE NO.

AN ORDINANCE OF THE CITY OF BETHLEHEM,
COUNTIES OF LEHIGH AND NORTHAMPTON,
COMMONWEALTH OF PENNSYLVANIA, AMENDING
THE 2020 CAPITAL BUDGET FOR NON-UTILITIES.

THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2020 Capital Budget for Non-Utilities be increased from Fourteen Million, Nine Hundred Eighty-Two Thousand, Twenty-One (14,982,021) Dollars to Sixteen Million, Three Hundred-One Thousand, Two Hundred Fifty-Six (\$16,301,256) Dollars.
