H2O PA Grant Application – Revision

DATE: February 27, 2020

On November 19, 2019, City Council passed Resolution No. 2019-248 in support of a H2O PA Grant application for a project to replace 4,300 ft. of sanitary sewer main along Broadway, Brodhead Avenue, and West Third Street in the City. The grant amount requested was for \$1,750,000. The application is currently under review by PA DCED with a decision expected by July 2020.

DCED's review has identified two items that warrant a revised resolution from City Council: a) an adjustment is needed in the cost estimate to reduce contingency; and b) a larger state match may be available for this project. The matching formula is two-thirds state – one-third city.

As a result of these recalculations, the total revised project cost is estimated to be \$3,214,709 (down from \$3,500,000), however the grant request will now be two-thirds of this new total or \$2,143,246. The attached draft resolution reflects this new grant request amount.

I respectfully ask that the resolution be placed on an upcoming Council meeting agenda in order to meet the filing deadline of March 23, 2020.
