## **ORDINANCE NO. 2020-**

## AN ORDINANCE OF THE CITY OF BETHLEHEM, COUNTIES OF LEHIGH AND NORTHAMPTON, COMMONWEALTH OF PENNSYLVANIA, AMENDING THE 2020 GENERAL FUND BUDGET.

### THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2020 General Fund Budget be increased from Eighty Million, Two Hundred-Sixty-Three Thousand, Four Hundred (80,263,400) Dollars to Eighty Million, Nine Hundred-Fifty-Seven Thousand, Eight Hundred Twenty (\$80,957,820) Dollars.
