Re:	2019 Substantial Amendment CDBG- CARES Act

The Department of Community and Economic Development is recommending a Substantial Amendment to the 2019 CDBG Action Plan incorporate CARES Act funding for disaster relief efforts resulting from the COVID-19 pandemic. CARES Act funding is a new allocation of funding.

In accordance with CDBG program regulations, the City is allowed to make substantial amendments to its Annual Action Plan and Budget in accordance with the City's Citizen Participation Plan.

Bethlehem has determined that it is necessary to amend the approved CDBG program budget for the previously approved program year FY 2019. This is considered a substantial amendment in accordance with Bethlehem's Citizen Participation Plan as the following applies: a) Adding or dropping an activity.

The amendment to the FY 2019 CDBG Annual Action Plan is proposed as follows:

In addition to funds provided through the CARES Act, the city will reprogram Program Income from the HOME Program to further assist in COVID-19 related relief efforts. These funds are as a result of repayment of previously loaned HOME funding. This funding is not being redirected from a current project.
