HISTORIC CONSERVATION COMMISSION

CASE #726 -- It is proposed to install a new sign and gooseneck lights at 203 East Third Street (ESSENCE Hookah Lounge).

OWNER / APPLICANT: Arch Beth Third, LLC and Beth Third Partners, LLC / John Skeparnias

The Commission upon motion by Ms. Starbuck and seconded by Mr. Silvoy adopted the proposal that City Council issue a Certificate of Appropriateness for the proposed work as presented, with modifications described herein:

- 1. The proposal to install a new sign and gooseneck lights was presented by John Skeparnias.
- 2. Approved signage includes the following details:
 - a. new sign measures 42-inches tall x 128-inches wide, to be painted directly onto stucco sign band and surrounded by 3-inch wide painted frame in warm white or ivory color; in preparation, existing awning and lighting to be removed while resulting damage to stucco sign band is repaired and background painted in black color
 - b. company logo on new sign includes word "ESSENCE" in large, bold, sans-serif, all upper-case lettering centered horizontally and within lower half of sign; stylized hookah pipe emanating smoke is combined with second letter "S"; justified right beneath logo are words "Hookah Lounge" in smaller, sans-serif lettering; all logo components are warm white or ivory in color
 - c. new sign to be centrally located above storefront entrance and aligned vertically with new signage at adjacent tenant at 201 East Third Street
- 3. Approved gooseneck lights include the following details:
 - a. four new fixtures to illuminate new signage to match four additional fixtures recently approved for adjacent tenant at 201 East Third Street
 - b. approved fixture is "Venice" (model name) wall-mount fixture manufactured by Steel Lighting Company, with 9-inch diameter angled reflector dome shade in black color; overall dimensions of proposed fixture are 15 ½-inches tall x 18 ½-inches wide
 - c. color temperature of LED lamps to be warm white (max. 3000 Kelvin)
 - d. Applicant to cooperate with adjacent tenant at 201 East Third Street to ensure total of eight new fixtures are evenly distributed across entire width of overall storefront; to be installed within top portion of frame around upper sign panel, with no resulting conduits, raceways, transformers and/or junction boxes visible on exterior façade

The motion for the proposed work was unanimously approved.
