HISTORICAL & ARCHITECTURAL REVIEW BOARD

APPLICATION #1: The Applicant proposes to install a free standing, ground level

patio/deck at 217 East Church Street.

The Board upon motion by Phil Roeder and seconded by Derrick Clark adopted the proposal that City Council uphold HARB's previous decision and recommendations from the 2 September 2020 meeting and issue a Certificate of Appropriateness for the following:

- 1. The decking shall be either wood or composite. If wood, it shall be manufactured of heartwood cedar, Spanish cedar, or mahogany and shall be ¾" thick by 2-3/4" wide. If composite, it shall be manufactured by Aeratis porch flooring and be 3-1/8" wide or by Azek porch flooring and be 3-3/8" wide.
- 2. The color of the decking material shall be a medium to dark grey.
- 3. The composite skirtboard shall be grey in color.
- 4. The decking shall overhang the skirtboard by 34" to 1".
- 5. The deck should be modified and box-outs around the windows should be installed to allow the windows to breath and get ventilation.
- 6. The fence shall be moved away approximately 3" to 6" and approved by the Zoning Officer.
- 7. The applicant must complete modifications within 60 days from the approval of C.O.A. and must notify Mr. Roeder and/or the Historic Officer, Mr. Phillips, when the work is completed.

The motion was unanimous to approve installation of detached, ground level patio constructed of pressure treated framing and grey composite or wood decking and to install two, premanufactured storage containers for bike and garbage can storage, as per the motion.
