Attached to this memo, please find a draft resolution in support of a grant application for the Multimodal Transportation Fund offered through the PA Department of Transportation. The project cost estimate as per URDC is \$363,740, and we are requesting \$213,740 to support the expansion of the Monocacy Way trail from Sand Island to Schoenersville Road. The project connects the existing trail to the D & L Corridor to further improve our trail system. We propose to use \$150,000 of existing Recreation Fees to complete the funding needed.

The City currently has grant funding to improve and expand the Monocacy Way trail from Schoenersville Road north to the Memorial Pool Complex and Illick's Mill. This northern stretch of the trail is funded with both DCNR funds and Northampton County Open Space funds. The project is in final design and construction is anticipated in 2021.

The proposed southern stretch will improve the trail and close the trail gap between the D & L trail and Schoenersville Road.
