HISTORIC CONSERVATION COMMISSION

CASE #738 -- It is proposed to replace the signage on the awnings at 117 East Third Street (The Blind Barrel).

OWNER / APPLICANT: Howard B. Altman / Howard B. Altman

The Commission upon motion by Mr. Evans and seconded by Mr. Hudak adopted the proposal that City Council issue a Certificate of Appropriateness for the proposed (already completed) work as presented, with modifications described herein:

1. The proposal to replace the signage on the awnings was presented by Gina Perini, Chris LaCroix and Neil Reinhard.
2. The approved replacement awnings include the following details:
 - a. existing frames for two individual awnings are to be retained for installation of new awning fabric; replacement awning canvas is Sunbrella #4608 (black)
 - b. one awning measures 34-inches high in addition to 10-inch high front valence flap while width is 201-inches and depth to building façade is 33 1/2-inches; second awning measures 34-inches high in addition to 10-inch high front valence flap while width is 238-inches and depth to building façade is 30-inches
 - c. each awning includes new company logo centered horizontally and vertically along pitched awning surface with following details:
 - i. 30-inch diameter outer circle with “BLIND BARREL” in upper portion and “BETHLEHEM, PENNSYLVANIA” in lower portion ... all upper-case, bold, serif lettering
 - ii. small central circle includes “Est. 2020” in serif lettering while remaining portion of circle graphic is divided into four quadrants ... with two sections containing stylized barrel graphic and two sections containing “B” in upper-case, bold serif lettering
 - iii. company name “THE BLIND BARREL” in all upper-case, bold, serif lettering measures 5 1/4-inches high and 82-inches wide centered horizontally and vertically along front valence flap of each replacement awning while street number “117” in italicized serif lettering appears at far left and far right of front valence flap of each replacement awning
 - iv. business logo, lettering and street numbers are ivory in color
- note:** HCC approval after project completion is contingent upon the removal of existing side panels at each awning location by the Applicant to comply with relevant design guidelines that awning ends remain open.
3. The decals for five storefront windows and one recessed entrance door include the company logo to match the new logo on the replacement awnings at 30-inches in

diameter with various lettering and graphics in ivory color; final approval to be secured by the Applicant from the Zoning Officer.

The motion for the proposed (already completed) work was unanimously approved.
