The Police Department is applying to receive up to \$152,438.41 in funding through the 2021 Local Share Account Northampton & Lehigh Counties grant. The grant will fund a project to install license plate reading cameras throughout the City. These devices will increase the rate and speed at which serious and violent crimes are solved.

The license plate readers, or LPR's, consist of high definition cameras designed to take a photograph of all vehicles passing through the focal point. The photographs are then processed via a proprietary computer software. The software compares the license plates captured against a master list of vehicles identified as being sought for a number of predetermined offences. In addition, when it is suspected that an unknown perpetrator of a crime left the scene in a vehicle, a search can be done of all the LPR's in the area and often times the vehicle can be located and the owner identified.

Although crime prevention through apprehension is the primary goal of any LPR system, there are other benefits as well. The ability to locate a particular vehicle in real time has proven to be instrumental in locating lost, missing or abducted persons. The Wind Creek casino (formerly Sands Casino) is frequented by a significant population of senior citizens. Often times when a senior with cognitive degeneration issues becomes confused or lost, their movements in and around the casino can be tracked. When they leave the casino property, however, there is currently no system in place in the City of Bethlehem to aid the police in bringing this beloved senior home safe.

The locations for this project include the area of Daly Ave that encompasses all roads in or out of the Wind Creek casino, the intersection of 3rd St and S New St and the intersection of Union Blvd and Club Ave on the City's border with Allentown. These areas were selected considering a combination of traffic density, ingress/egress from Allentown as well as frequency of use by those involved in casino related incidents.

Bethlehem has found itself significantly behind in the use of advanced technology to augment Police patrol and investigation. This project will begin to put us on par with surrounding jurisdictions and other cities of similar size and crime rates.
