• Reasons for recommendation of Administration and Council approval of contract:

During construction of the upgrade of the traffic signal at the Elizabeth Ave and Linden St. intersection, a significant amount of additional curb, sidewalk and ADA ramp work was required than was previously anticipated to meet federal criteria in terms of maximum grade, transition areas, etc. This included both removal of existing areas and installation of new sidewalks and curb. In addition, an area of pavement adjacent to a new ADA ramp was found to be in disrepair (note that there was a significant lag between the time of design and time of construction due to delays in securing bids as a result of the pandemic) and the City requested that the contractor repave the area to prevent further damage or future issues. Finally, some of the pavement marking quantities were increased based on poor existing conditions in the field.

The additional work completed on the pavement and ADA ramps / sidewalks has given the City (and abutting Liberty High School) a safer and more complete project.
