Since the 911 Center moved to Northampton County, the street name of North and South Easton Roads as they cross into another municipality within the County have caused confusion.

South Easton Road in the City crosses into Lower Saucon Township. The Lower Saucon Township section of the road (south side) is simply Easton Road. Now that we share a database with Lower Saucon Township, having multiple street names for one street has become an issue for the GIS. It is recommended that the City rename South Easton Road to just Easton Road in order to match with Lower Saucon Township.

The City also has a North Easton Road which is located on the other side of the LVIP/Majestic development off of Applebutter Road. This roadway is approximately 1300 feet in length within the City of Bethlehem. Once the roadway crosses over the City's boundary into Lower Saucon Township, it changes names to Skyline Drive. There are currently only 5 parcels within the City that utilize the North Easton Rd address. It is recommended that the City rename North Easton Road to Skyline Drive.
