## Dear Attorney Vidoni:

Please consider this correspondence as my client's request for an intermunicpal transfer of liquor license into the City of Bethlehem at the above location, pursuant to 47 P.S. § 4-461(b.3). Under this statute, please note that a public hearing (duly advertised) must be held by the municipal governing body for the purpose of receiving comments and recommendations of interested individuals residing within the municipality relative to my client's application. In addition, the City Council must render a decision within 45 days of the request. In my experience before your Honorable Council, the hearings have been conducted at a legislative forum to ascertain whether moving the license into the City at a particular location would adversely affect the welfare, health, peace and morals of the municipality. Typically, the hearings have not been specially listed at their own times, but have been specially listed agenda items of regular City business. Further, the hearings have been conducted as the first order of business. It would be greatly appreciated if this matter could be added to City of Bethlehem's Council agenda to be read into the record on April 4<sup>th</sup> and the hearing scheduled for April 19<sup>th</sup> in order for our client and the City to meet their legal requirements.

The proposed site is located at 410 Montclair Avenue, Bethlehem, and I welcome the City Council to review zoning records in this regard. My client will operate a grocery store at the site and intends to add the additional convenience of beer and, potentially, wine offerings at its grocery store. We have also provided a Summary of Food Offerings, the draft Transfer Application to the Pa.L.C.B., and the proposed Notice of the hearing to be provided to neighboring property owners within a 500 feet radius of the proposed site. Should you have any questions, concerns, or need any additional information regarding my client's proposal prior to

the hearing, please do not hesitate to contact me. Lastly, attached is a copy of the proposed Resolution approving the transfer.

We are also providing a check in the amount of \$200.00 representing the City's required fees. If additional fees are required, please advise and we will promptly forward the same.

Additional information regarding the applicant will be provided upon request. Please confirm when my client's request is scheduled to be heard by Bethlehem City Council. By copy of this correspondence, we are providing Brian Panella, City Council Solicitor, of this request.

# NOTICE OF FILING OF INTERMUNICIPAL LIQUOR LICENSE REQUEST WITH THE CITY OF BETHLEHEM, NORTHAMPTON COUNTY, PA

Notice is hereby given pursuant to City of Bethlehem Resolution No. 2012-114 that a request for intermunicipal transfer of liquor license has been filed with the City of Bethlehem for the transfer of a restaurant liquor license to property located at 410 Montclair Avenue, Bethlehem, Northampton County, Pennsylvania.

The request was filed on behalf of Montclair Meat & Food Corp., Bethlehem, Northampton County, Pennsylvania. This request and information in connection with the proposed Transfer Application to be submitted to the Pennsylvania Liquor Control Board can be reviewed during normal business hours at the offices of David C. Berger, Esquire, Norris McLaughlin, P.A., 515 West Hamilton Street, Suite 502, Allentown, PA 18101; telephone 610-391-1800.

The City of Bethlehem Council will conduct a Public Hearing regarding this request during the City Council Meeting on Tuesday, April 19, 2022, at 7:00 P.M. in Town Hall, 10 East Church Street, Bethlehem, PA 18018.

### **RESOLUTION NO. 2022-**

WHEREAS, Section 461 of the Pennsylvania Liquor Code (47 P.S. 4-461, hereinafter "Code") authorizes, among other things, the Pennsylvania Liquor Control Board (hereinafter "PLCB") to approve the transfer of liquor licenses across municipal boundaries within the same county and under certain conditions to issue restaurant and eating place retail dispenser licenses without regard to quota restrictions for the purpose of economic development; and

WHEREAS, subsection (b.3) of Section 461 requires that an intermunicipal transfer or issuance of a new license for economic development must, under certain conditions, first be approved by the governing body of the receiving municipality; and

WHEREAS, that subsection also requires that a receiving municipality issue a resolution approving or disapproving the intermunicipal transfer or issuance of a new liquor license prior to submission of an application for such transfer to the PLCB; and

WHEREAS, that subsection mandates that, prior to adoption of such a resolution, at least one hearing be held for the purpose of receiving comments and recommendations from interested individuals residing within the receiving municipality concerning the intent to transfer the license into the municipality or the issuance of an economic development license; and

WHEREAS, Montclair Meat & Food Corp. leases property located at 410 Montclair Avenue, Bethlehem, Northampton County, PA and intends to operate a grocery store at such location; and

WHEREAS, on \_\_\_\_\_\_\_, 2022 and pursuant to Section 461, the Applicant's request was received for approval by City Council, City of Bethlehem, Northampton County (hereinafter "Council") of a proposed intermunicipal transfer of Retail Restaurant Liquor License No. R-14009. The license was previously issued to Valley Pizza, Inc. for licensed premises located at 503 Old Main Street, P.O. Box 5, Walnutport, Northampton County; and

WHEREAS, on \_\_\_\_\_\_\_, 2022 and in accordance with Section 461 (b .3) Council held a public hearing on the proposed liquor license transfer; and

WHEREAS, the purpose of this Resolution is to comply with Code Section 461 (b.3).

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Bethlehem, Northampton County, Pennsylvania as follows:

- 1. Applicant seeks approval of an intermunicipal transfer of Retail Restaurant Liquor License No. R-14009 which was previously issued to Valley Pizza, Inc., for licensed premises located at 503 Old Main Street, P.O. Box 5, Walnutport, Northampton County to 410 Montclair Avenue, Bethlehem, Northampton County, Pennsylvania, pursuant to Code Section 461.
- 2. Applicant proposes to, and will, operate a grocery store with carry-out beer and wine at the aforedescribed location.
  - 3. The Applicant's proposal is a permitted use at this location.
- 4. The Applicant's proposed grocery store with carry-out beer and wine is in a General Commercial ("CG") zoning district.
- 5. There is no evidence that the proposed, intermunicipal transfer will adversely affect the welfare, health, peace and morals of this City or the residents hereof.
- 6. Council hereby approves the Applicant's request for an intermunicipal transfer of Pennsylvania Liquor License No. R-14009 pursuant to Code Section 461 (b.3).
- 7. The transfer of the Liquor License contemplated hereby is subject to final approval by the PLCB.
