	<b>RE:</b>	Resolution for Adoption of "George" – Mounted Unit Equine

At the recommendation of veterinary staff, the Bethlehem Police Department retired police equine "George" from active duty in 2020 due to lameness and neurologic issues.

George was purchased in 2009 by the City of Bethlehem with federal funding through the Edward Byrne Memorial Justice Assistance Grant (JAG) (2009-SB-B9-1591) that was awarded March 1, 2009.

The Bethlehem Police Department is seeking approval to properly retire George per grant compliance guidelines and Third Class City Code.

If approved, ownership will be transferred to the Friends of the Bethlehem Mounted Police, a 501(c) (3) non-profit organization, so that he may be able to live out the remainder of his life in a happy and loving environment. Per grant guidelines, the transfer will commence at a fair market value of \$500.00.

I respectfully request permission from Council, under 11 Pa.C.S. §12402.1 of the Third Class City Code, to officially retire George and transfer him to the Friends of the Bethlehem Mounted Police.

BE IT FURTHER RESOLVED, now that George is retired, he can relax and enjoy all that life has to offer him; and

BE IT FURTHER RESOLVED that George is extended every good wish for a long and happy retirement; and

BE IT FURTHER RESOLVED by the Council of the City of Bethlehem that George is hereby approved to be transferred by the Bethlehem Police Department to the Friends of Bethlehem Mounted Police:
