Due to his age and inability to perform his duties in a safe manner, the Bethlehem Police Department is seeking to retire police equine "Pharaoh" from active duty.

Pharaoh was purchased in 2009 by the City of Bethlehem with federal funding through the Edward Byrne Memorial Justice Assistance Grant (JAG) (2009-SB-B9-1591) that was awarded March 1, 2009.

The Bethlehem Police Department is seeking approval to properly retire Pharaoh per grant compliance guidelines and Third Class City Code.

If approved, ownership will be transferred to the Friends of the Bethlehem Mounted Police, a 501(c) (3) non-profit organization, so that he may be able to live out the remainder of his life in a happy and loving environment. Per grant guidelines, the transfer will commence at a fair market value of \$500.00.

I respectfully request permission from Council, under 11 Pa.C.S. §12402.1 of the Third Class City Code, to officially retire Pharaoh and transfer him to the Friends of the Bethlehem Mounted Police.
