The contract shall run from the Notice to Proceed until December 31, 2024.

• Description of project or scope of services to be provided:

This is a goods and services contract for transportation and disposal of Class B Biosolids from the wastewater treatment plant to beneficial use sites operated by the Contractor and approved by PaDEP. Alternative methods of disposal include either offsite processing or the City's backup landfill should the Biosolids not meet regulatory requirements for beneficial use.

• State the actual or estimated price to the City or the proposed Department budget allowance for the initial term; and state payment rate per unit of service if applicable:

Beneficial Use Pricing
Fuel Component = \$16.50 per wet ton
Non-Fuel Component = \$24.75 per wet ton

Initial contract term will cover a two (2) year period (CY 2023-2024), with an option for three (3) additional one (1) year extensions (2025, 2026, 2027).

 Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

Fuel Component price will be adjusted annually (up or down) based on the change in average diesel fuel price compared to the baseline price at time of bid.

Non-Fuel Component price will be adjusted annually (up or down) based on the change in the Consumer Price Index during the previous 12-month period.

• Reasons for recommendation of Administration and Council approval of contract:

Three proposals were received. Synagro Central, LLC is the lowest responsible bidder. The City recommends award of the contract to Synagro Central.
