HISTORICAL & ARCHITECTURAL REVIEW BOARD

APPLICATION #2: The applicant/owner of the property located at 418 High Street proposes to replace the existing slate roofing on the porch with GAF Slateline shingles in the Antique Slate Color and replace miscellaneous rusted down spouts. The new downspouts will be round to match the existing.

The Board upon motion by Diana Hodgson and seconded by Connie Postupack adopted the proposal that City Council issue a Certificate of Appropriateness to replace the existing slate porch roofing with GAF Slateline shingles in the Antique Slate color and replace miscellaneous rusted downspouts with round downspouts that match the existing downspouts, with the following conditions.

1. Metal valleys and drip edges will be painted red to match the existing.
2. Existing half round gutters will remain.
3. New metal downspouts will match the existing downspouts and will be painted red to match existing.
4. Any other painting of trim or other building materials will be submitted to HARB for review prior to commencing the work.

The vote was unanimous to approve the removal of the existing roof shingles and replace them with GAF Slateline Shingles in the Antique Slate Color, as per the motion.

Guideline Citation:

Secretary of Interior Standards No.(s)

#9 New additions, exterior alterations, or related new construction will not destroy historic materials, features, and spatial relationships that characterize the property. The new work shall be differentiated from the old and will be compatible with historic materials, features, size, scale and proportion, and massing to protect the integrity of the historic property and its environment.

#10 New additions and adjacent or related new construction will be undertaken in such manner that, if removed in the future, the essential form and integrity of the historic property and its environment would be unimpaired.

Bethlehem Historic District Design Guidelines

Page 7: Roofing: The HARB encourages, Replacement of roofing materials when beyond repair, matching original color, pattern, material and texture.

Gutters & Downspouts: The HARB encourages installing half-round gutters and plain round downspouts.

Drip Edges: The HARB encourages painting drip edges to match adjacent trim.

Evaluation, Effect on Historic District, Recommendations: The proposed work conforms with the intent of the Secretary of the Interior's Standards for Rehabilitation and the Bethlehem Historic District Design Guidelines/Guidelines for Sustainability and will have no negative impact to the historic district.
