4. Term of contract or estimated completion date, subject to standard extensions:

The contract will commence on January 1, 2023. The contract term shall be twenty-four (24) months. After the expiration of the initial contract term on December 31, 2024, the City and the Contractor shall have the option for five (5) additional renewal terms of one (1) year each upon mutual consent of the parties.

5. Description of project or scope of services to be provided:

The contract is for the curbside collection of recyclables for the City of Bethlehem in a single-stream fashion.

6. State the actual or estimated price to the City or the proposed Department budget allowance for the initial term; state payment rate per unit of service if applicable:

The price of the initial two-year term of the contract is \$3,523,212. That is broken down by Year 1 \$1,718,640; Year 2 \$1,804,572

7. Number of renewal term options and duration of each renewal, if any:

After the expiration of the initial contract term, the City and the Contractor shall have the option for five (5) additional renewal terms of one (1) year each upon mutual consent of the parties.

8. Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

The bid specifications state that the contract will be renewed for the allowable additional terms if the maximum price escalation is no more than five (5%) percent for each renewal year. Give that anticipated 5% escalation each year, the estimated not to exceed to exercise all renewals would be \$10,469,971.

8. Reasons for recommendation of Administration and Council approval of contract:

After the current vendor for the City's curbside recycling service did not exercise the option for an extension of the existing contract, the City put out a public request for bids from qualified and experienced firms to provide curbside recycling services under a new two-year contract. The City of Bethlehem received sealed bids online via PennBid for Bid 2022 53 Curbside Recycling on October 13, 2022. The bids were reviewed, and the City recommends the base bid for curbside collection of recyclables throughout the City of Bethlehem in a single-stream fashion be awarded to Republic Services of New Jersey LLC d/b/a Raritan Valley Disposal for a two-year contract that will total \$3,523,212.

Please approve this recommendation by passing the accompanying resolution. A vote of final approval is requested at the first City Council agenda listing of this matter.
