Please have City Council's Finance Committee consider the following amendments:

- 1. Reinstate expenditure account 0302-42172E, MCH Escrow, with a balance of \$ 7,000 from \$ 0 to \$ 7,000 for Partner's for a Healthy Baby program items not covered by the grant.
 - a. Increase revenue account 001-30402, Grants and Gifts City Health, by \$7,000 from \$2,465,922 to \$2,472,922.
- 2. Increase expenditure account 0302-42190E, Chronic Disease Escrow, by \$ 102,000 from \$ 22,000 to \$ 124,000 to pay for Re-accreditation status for next 5 year cycle (\$12,000); receipt of grants from the Two Rivers Foundation (\$15,000) and the United Way (\$ 75,000) both for support of the Project LifeSaver Program.
 - a. Increase revenue account 001-30402, Grants and Gifts City Health, by \$ 102,000 from \$ 2,472,922 to \$ 2,574,922.

Bethlehem received a DEP grant from the State in the amount of \$264,900 for the purchase of a John Deere loader.

This is a reimbursement grant; when the funds have been fully expended by the city, then the city will request reimbursement from DEP. The city is required to pay 10% of the purchase price.

Delivery of the loader has been rescheduled several times, the original delivery date was December 2021. However, due to part shortages delivery has been pushed back to April 2022. The funds were originally budgeted in 2021 however due to the most recent delay the funds will need to be drawn from the 2022 budget. Therefore, the projected revenue and expense associated with this grant were not included in the 2022 budget. It is our recommendation that the following budget adjustments be considered for approval.
