Bethlehem received an allocation from the US Department of Housing and Urban Development for 2022 Community Development Block Grant and HOME Investment Partnerships totaling \$1,822,460. \$1,391,666 has been allocated to CDBG and \$430,794 has been allocated to HOME.

Projected revenue and expenses associated with this grant were not included in the 2022 Budget. It is our recommendation that the following budget adjustments be considered for approval.

AN ORDINANCE OF THE CITY OF BETHLEHEM, COUNTIES OF LEHIGH AND NORTHAMPTON, COMMONWEALTH OF PENNSYLVANIA, AMENDING THE 2022 COMMUNITY DEVELOPMENT BLOCK GRANT BUDGET

THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2022 Community Development Budget be increased from of Five Million, Three Hundred Eighty-Seven Thousand, Two (\$5,387,002) Dollars to Seven Million, Two Hundred Nine Thousand, Four Hundred Sixty-Two (\$7,209,462) Dollars.
