**ORDINANCE NO. 2023-**

AN ORDINANCE OF THE CITY OF BETHLEHEM,  
COUNTIES OF LEHIGH AND NORTHAMPTON,  
COMMONWEALTH OF PENNSYLVANIA, AMENDING  
THE 2023 COMMUNITY DEVELOPMENT BLOCK GRANT  
BUDGET

THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2023 Community Development Budget be decreased from Five Million, Six Hundred Ninety-Nine Thousand, Four Hundred Sixteen (\$5,699,416) Dollars to Five Million, Five Hundred Seventeen Thousand, Five Hundred Forty (\$5,517,540) Dollars
