**ORDINANCE NO. 2023-**

AN ORDINANCE OF THE CITY OF BETHLEHEM,  
COUNTIES OF LEHIGH AND NORTHAMPTON,  
COMMONWEALTH OF PENNSYLVANIA, AMENDING  
THE 2023 CAPITAL BUDGET FOR SEWER UTILITIES.

THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2023 Capital Budget for Sewer Utilities be increased from Eleven Million, Five Hundred Twenty-Seven Thousand, Six Hundred Seventy-Nine (\$11,527,679) Dollars to Thirteen Million, Five Hundred Forty-Seven Thousand, Six Hundred Seventy-Nine (\$13,547,679)

SECTION 2. That the following allocations be changed:
