PRO Housing Grant Application Resolution

In September, Bethlehem City Council authorized the Department of Community and Economic Development (DCED) to apply for a federal Pathways to Removing Obstacles to Housing program (PRO Housing) grant for up to \$10,000,000. This funding would support the Administration's implementation of the City's Comprehensive Housing Strategy.

PRO Housing grants are administered by the U.S. Department of Housing and Urban Development (HUD) and are designed to help communities identify and remove barriers to affordable housing production and preservation. Eligible uses include activities that further develop, evaluate, and implement housing policy plans, improve housing strategies, and facilitate affordable housing production and preservation. This grant opportunity comes with a tight timeline and the application must be submitted to HUD by October 30, 2023.

We plan to use this grant to support design and implementation of affordable housing incentive programs and a related revolving loan fund. Moreover, the grant would augment DCED's capacity to prepare and evaluate zoning update recommendations from the Administration's Opening Doors plan. In addition to other potential uses, the grant would enable the City to provide additional financial support to several homelessness/eviction prevention programs operated by our nonprofit community partners.

The grant requires the City make its application available for public comment for at least 15 days and incorporate any feedback into our application. We also must conduct a public hearing and obtain Council approval of the plan detailed in the application. The application was posted for comment on October 10, 2023 and the public comment period will end October 25, 2023. The required public input process is similar to our CBDG/HOME Annual Action place process.

We respectfully request City Council schedule a public hearing at the start of its October 17, 2023 meeting and place a resolution approving the grant application and plan on that evening's agenda for consideration and a vote. We apologize that the grant's tight timeline did not allow for us to submit this request prior to Council's last meeting on October 3, 2023.
