

Campaign: Yield to Pedestrians - Slow Down, Look Around

Concept

Walking, the original and most fundamental form of transportation, is also the most underrated form of exercise. CAT's Yield to Pedestrians Campaign will educate drivers on laws and encourage them to slow down and look around. The desired outcome is to improve public health, reduce traffic injuries and deaths, and create a more enjoyable experience to walk and/or operate a wheelchair in the Lehigh Valley.



Background Data & Survey Results

Between 2001-2021, Pedestrians Struck by Cars in "reportable" crashes:

PA Statewide: 91,730 (11,132 pedestrians killed or seriously injured (KSI) by motorists), Lehigh Valley: 4,898 (536 pedestrians KSI), City of Bethlehem: 799 (with 68 pedestrians KSI)



Lehigh Valley community responses to CAT Yield to Pedestrians Survey 2022-2023:

- What people say are the top 3 problems with drivers:
- 86% say "Drivers don't pay attention"
- 81% say "Drivers going too fast/speeding"
- 80% say "Drivers don't yield when I'm in the crosswalk"

CAT Yield to Pedestrians Campaign Details Audience

All drivers (cars, trucks, buses, bicycles) and pedestrians in the Lehigh Valley (~650,000 people across Lehigh and Northampton counties including 62 municipalities)

Promotion

The campaign will feature large street banners, printed posters, social/online media, and radio segments all with positive messaging that depicts drivers yielding to pedestrians, reminding them to slow down and look around.

- March 2022 June 2023 Pre-campaign surveys
- June 1 August 31, 2023 Banners, PSA's, window posters
- June 7, 2023 Kick off Press Conference
- June 7 July 7, 2023 "Slow Down, Look Around" Street Banners, 5 locations in Bethlehem
- June 10, 2023 Pedestrian Party Event at Bethlehem Rose Garden Farmers' Market
- June 10 July 6, 2023 Partnering @community events (see below), farmer's markets, festivals
- September December 2023 Post-campaign surveys

Each in-person event will offer free swag, games, and prizes. Events will also have special photo-ops.

- Support lowering speed limits on Broad St, Union Blvd, Stefko Blvd, 3rd/4th Streets (southside)
- Increase speed/aggressive driver enforcement & enforcement of driver yield to pedestrian laws during June 2023 and going forward.
- Speak at Kick Off Press Conference (6/7/2023) and join CAT at Rose Garden event (6/10/2023)
- Promote CAT Yield to Pedestrians Campaign through Mayor's office and City social media & outreach
