The update of the capital value of the water system will include a bring-forward of the original cost of utility plant by account as of December 31, 2023, including an estimate of the retirements associated with the plant additions. In addition, the book reserve will be determined as of the same date, and calculations of annual and accrued depreciation will be performed. A summary schedule presenting the results of the calculations will be provided by April 15, 2024.
