**ORDINANCE NO. 2024-\_\_\_\_\_**

AN ORDINANCE OF THE CITY OF BETHLEHEM,  
COUNTIES OF LEHIGH AND NORTHAMPTON,  
COMMONWEALTH OF PENNSYLVANIA, AMENDING  
THE 2024 CAPITAL BUDGET FOR WATER UTILITIES.

THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2024 Capital Budget for Water Utilities be decreased from Eight Million, Four Hundred One Thousand, Nine Hundred Ninety-Five (\$8,401,995) Dollars to Eight Million, Eleven Thousand, One Hundred Forty-Four (\$8,011,144) Dollars.

SECTION 2. That the following allocations be changed:
