Re: Ordinance Amending Article 347 of the City's Codified Ordinances

Date: May 29, 2024

Enclosed for Council's review and action is a proposed ordinance amending Article 347 of the City's Codified Ordinances, which is titled "Municipal Claims for Delinquent Accounts – Schedule of Attorneys Fees to be Added." The proposed ordinance amends Section 347.02, titled Schedule of Fees, to add a subsection (h) to include a fee charged by Portnoff Law Associates, Ltd. for providing a guaranteed payoff amount as to any delinquent accounts. Portnoff is retained to collect the City's delinquent accounts for taxes, water/sewer fees, and stormwater user fees. The fee in the proposed amendment, which is requested by Portnoff, is akin to a fee charged by a county or municipality for a tax certification. The fee is not charged to the City nor is it added to the delinquent amount of any property's account; rather, the fee is charged to the person requesting the payoff amount, such as in the case of an individual seeking to purchase a property in order to confirm whether and in what amounts there are any tax, water/sewer, and/or stormwater user fee delinquencies on that property.
