ORDINANCE NO. 2024-_____

AN ORDINANCE OF THE CITY OF BETHLEHEM,
COUNTIES OF LEHIGH AND NORTHAMPTON,
COMMONWEALTH OF PENNSYLVANIA, AMENDING
THE 2024 CAPITAL BUDGET FOR NON-UTILITIES.

THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2024 Capital Budget for Non-Utilities be increased from Twenty-Six Million, Three Hundred Fifteen Thousand, Two Hundred Ninety-Nine (\$26,315,299) Dollars to Twenty-Six Million, Five Hundred Four Thousand, Two Hundred Ninety-Nine (\$26,504,299) Dollars.
