Multimodal Transportation Fund – Guetter Street Sidewalks and ADA Ramps

On July 15, 2025, City Council adopted a resolution authorizing the City of Bethlehem to proceed with a grant application to the PA Department of Community and Economic Development for a Multimodal Transportation Fund grant in support of improvements on Guetter Street, in front of the Transportation Center. Since submitting that grant, PA DCED has requested an updated resolution that highlights the specific funding amount. This updated resolution supersedes the previous action by specifying the exact amount to be requested, \$340,625, and formally authorizing submission of the application with this amount.

Attached is this updated resolution in support of our application for the Multimodal Transportation Fund through PA DCED. The grant request is for \$340,625 and includes funds to improve the sidewalks on Guetter Street, in front of the Transportation Center, repair the roadway, and update the ADA ramps. This work will be completed in collaboration with the Bethlehem Parking Authority and LANTA, which already installed new awnings and bus shelters near this location.
