AN ORDINANCE OF THE CITY OF BETHLEHEM,  
COUNTIES OF LEHIGH AND NORTHAMPTON,  
COMMONWEALTH OF PENNSYLVANIA, AMENDING  
THE GENERAL FUND BUDGET FOR 2025.

THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2025 General Fund Budget be increased from One Hundred Twelve Million, Two Hundred Fifteen Thousand, Four Hundred Ninety-Seven (\$112,215,497) Dollars to One Hundred Twelve Million, Two Hundred Fifteen Thousand, Seven Hundred Forty-Seven (\$112,215,747) Dollars.
