ORDINANCE NO. 2025-_____

AN ORDINANCE OF THE CITY OF BETHLEHEM,
COUNTIES OF LEHIGH AND NORTHAMPTON,
COMMONWEALTH OF PENNSYLVANIA, AMENDING
THE 2025 CAPITAL BUDGET FOR NON-UTILITIES.

THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2025 Capital Budget for Non-Utilities be increased from Twenty-Eight Million, One Hundred Twenty Thousand, Four Hundred Sixty-Four (\$28,120,464) Dollars to Twenty-Eight Million, One Hundred Seventy Thousand, Four Hundred Sixty-Four (\$28,170,464) Dollars.
