ORDINANCE NO. 2026-_____

AN ORDINANCE OF THE CITY OF BETHLEHEM,
COUNTIES OF LEHIGH AND NORTHAMPTON,
COMMONWEALTH OF PENNSYLVANIA, AMENDING
THE 2026 BUDGET FOR NON-UTILITY CAPITAL FUND.

THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2026 Budget for Non-Utility Capital Fund be increased from Thirty-Nine Million, Twenty-Five Thousand, Three Hundred Twenty-Three (\$39,025,323) Dollars to Forty-One Million, Two Hundred Seventy-Eight Thousand, One Hundred Nineteen (\$41,278,119) Dollars.
