**ORDINANCE NO. 2026-\_\_\_\_\_**

AN ORDINANCE OF THE CITY OF BETHLEHEM,  
COUNTIES OF LEHIGH AND NORTHAMPTON,  
COMMONWEALTH OF PENNSYLVANIA, AMENDING  
THE WATER CAPITAL FUND BUDGET FOR 2026.

THE COUNCIL OF THE CITY OF BETHLEHEM HEREBY ORDAINS:

SECTION 1. That total appropriations in the 2026 Capital Budget for the Water Fund be decreased from Twelve Million, Eight Hundred Twenty-Four Thousand, Forty (\$12,824,040) Dollars to Twelve Million, Four Hundred Ninety-Seven Thousand, Six (\$12,497,006) Dollars.

SECTION 2. That the following allocations be changed:
