

5" K-Style: Designed with a collection opening of 4.25" and capable of holding 2.5 quarts of water per foot. Used in conjunction with 2" x 3" downspouts.

6" K-Style: Designed with a collection opening of 5.25" and a holding capacity of 4 quarts of water per foot. Used in conjunction with 3" x 4" downspouts.

On both types of gutter we use a premium Hidden-Hanger with a screw-anchoring method versus the older spike and ferrule method

Half-Round: Seamless Half-Round Installation uses exposed bracket hangers.







Home Genius Exteriors: Home owner is responsible for 4'x8' sheet of plywood replacement at additional cost unless specified above in the contract. Plywood will be replaced to match existing thickness. Plywood is only to be replaced when existing plywood is rotten.

Existing gutter protection products will be disturbed upon the removal of shingles. Home Genius Exteriors is not responsible for damages caused to existing gutter protection products during installation.

Additional costs could arise due to damaged wood not recognized at time of estimate. Any wood replacement on the roof deck will be charged at an additional cost of \$5.88/sq ft. This includes all freight, taxes, material, and labor install of sheathing replacement.

Homeowner understands that damaged plywood can only be evaluated after the existing layer(s) of shingle(s) have been removed.

Homeowner understands that an adjustment to the pitch of the roof is not part of the scope. For minor pitch adjustments with the use of insulation board, especially on low slope roofs, Home Genius Exteriors charges \$3.75/sq ft.

Homeowner understands that unforeseen additional layer tear offs will be charged accordingly: Additional cost of \$0.75/sq ft. for each layer of asphalt tear off and \$2.675/sq ft. for each layer of slate and \$7.07/sq ft. for cedar tear off and re-decking (plywood material included).

Homeowner understands that additional tear off and unforeseen damage may result in additional dumpsters. Number of Dumpster(s) and size is outlined in above contract.

Homeowner has completely read, and fully understands that any and all plywood replacement or additional layer tear off will be charged in addition to the total amount of this contract.

Access is needed to driveway where possible. Please have all vehicles removed from driveway to allow for material delivery.

Any belongings inside of your home especially in attic and the top floor shall be the responsibility of the homeowner to protect. Please secure all loose items prior to installation. Also please be aware that saw dust and debris can fall inside of the attic during the installation.

Home Genius Exteriors is not responsible for any nail pops or cracks that occur during installation.

Home Genius Exteriors will use a magnetic sweep to collect nails multiple times throughout the project - especially at the end. Please keep in mind that this is most effective when the grass is cut.

All ventilation will be installed by Home Genius Exteriors Discretion. Project Manager and Install team members will determine placement of intake and outtake vents.

It is the customers responsibility to arrange any solar panels and satellite dish removal, calibration, and reinstallation.

Existing gutters and/or gutter protection products will be disturbed upon the removal of shingles. Home Genius Exteriors is not responsible for damages caused to existing gutters and/or gutter protection products during installation.

It is customer responsibility to disclose any A/C and/or Electrical wiring that is installed to the sheathing underside of the roof deck. Home Genius is not responsible for damages performed to the inadequate placement of A/C lines and/or electrical lines.

TERMS & CONDITIONS

- 1. COLOR CHANGES. All paint colors must be chosen by you before any work is done. If during the color selection process, it becomes evident that the color choice will not provide adequate coverage without an additional coat, you will be presented with the cost of the additional coat. If you decline the change order, Contractor will not be liable for inadequate coverage.
- 2. HIDDEN CONDITIONS. If, after beginning work, defects or other unforeseen conditions are discovered which could not reasonably have been discovered by Contractor during the estimate (e.g., invisible defects, hazardous materials, etc.), you will be charged on a time and materials basis plus a standard markup for overhead and profit on the additional costs incurred as a result of such conditions.
- 3. TERMITES AND PESTS. Client understands that HGE is not qualified or licensed as an inspector for pests (including Termites). Should any such pests be suspected to be present on the premises, it is the Client's responsibility to arrange and pay for inspection and abatement. HGE cannot certify or warrant your building as being free of pests.
- 4. ANTENNAS and SATELLITE DISHES: Should it become necessary for HGE to remove and/or install any antennas, cooling or heating appliances or other equipment, HGE does not assume any responsibility for the performance of said equipment, whether or not such performance problems are the result of the negligent acts or omissions of HGE or its employees.
- 5. PERMITS, LICENSES, AND REGULATIONS: Permits and licenses necessary to complete the work agreed upon in this Contract will be obtained by HGE and paid for by Client. Client agrees to assist HGE in obtaining such permits and licenses. Client is responsible for all costs for drawings and structural calculations.
- 6. WORKMANSHIP & WARRANTY: The Scope of Work will be performed in a manner consistent with manufacturer specifications and building codes. The warranty period will commence upon substantial completion according to the specific Scope of Work on each building. This limited warranty is expressly conditioned on HGE having reasonable opportunity to inspect the alleged defect, and HGE receipt of payment in full pursuant to this Contract and any Change Orders signed thereafter.
- 6.1. PAINT WARRANTY: HGE will provide a limited warranty to repair peeling, blistering and/or chipping paint which are a result of defective workmanship for a period of one (1) year from the date of substantial completion.
- 6.2. SIDING AND WINDOWS WARRANTY: Unless stated otherwise in this Contract, standard workmanship warranty for siding replacement, or windows replacement is one (1) year from the date of substantial completion.
- 6.3. ROOF WARRANTY: Unless stated otherwise in this Contract, standard workmanship warranty for roofing is two (2) years from the state of substantial completion. The warranty is limited to roof leaks and replacement of missing shingles but does not include repair or reimbursement for water damage to the interior of the home. HGE is not responsible for any leaks or water damage below the roof line including excessive wind, ice or hail.
- 6.4. LIMITATIONS ON COVERAGE: HGE will not be liable for conditions outside of its control, including but not limited to the following: a) failure due to physical abuse; b) failure or damage due to structural settling or distortion; c) failure due to structural settling; e) fungus, bacteria, infestation, and UV degradation; f) failure due to rust or corrosion resulting in metal or wood decay; g) vandalism; h) tenant abuse; and i) termite damage; j) failure or damage caused by acts of God including but not limited to: tornados, hurricanes, lightning, ice damage, hailstorms or impact of foreign objects, wind gusts exceeding published product specifications; h) failure due to physical abuse; i) failure occurring on any flat or horizontal surface and/or any surface that allows moisture to collect; j) fading colors; h) failure on surfaces made of or containing galvanized metal; k) bleeding caused by knots or rust; and j) failure of previous layers and/or coating of paint why may or may not have been present or visible at the time of paint application. Warranty is limited to repainting of original affected area. Warranty work is performed between the months of July and September following timely notice of a claim.
- 6.5. NO OTHER WARRANTIES. There are no other terms, conditions, covenants, representations, or warranties, express or implied out of common statutory law, with regard to quality, quantity, fitness, habitability or otherwise with respect to this contract other than those contractor's warranties expressly set forth in this section on contractor warranties.

- 7. MEDIATION: Before any legal remedy may be sought to resolve any controversy or claim which has arisen as a direct or indirect result of this Contract, its performance, or the breach thereof, it is agreed that the Parties will submit to a mediator jointly selected by the Parties. If the Parties are unable to agree to a mediator, then upon the written request of either party, the mediator will be selected by and appointed by the administrator of the American Arbitration Association. All costs for mediation will be borne equally by the Parties. This provision will not apply to any action brought to enforce a mechanic's lien or stop notice.
- 8. MOLD DISCLAIMER. This contract does not include, any mold abatement, removal, or cleaning. If mold is found existing on the premises, any cost to abate, remove, or clean shall be paid by you as an extra. In addition, any warranty given to you under this contract does NOT include the cost to abate, remove, or clean mold that may be found on the premises in the future.
- 9. SPECIAL CONDITIONS AND CONSIDERATIONS. The Scope of Work is based on a visual inspection. While performing this Contract, should HGE discover dry rot, sub-roof deterioration or other damaged building elements that were not apparent during the inspection, and which are determined to need removal and replacement, HGE will notify Client of the additional work and any charge associated with completing the additional work. Should Client decide not to have HGE perform the additional work, Client understands that the failure to perform the additional work may affect the warranty.

10. OTHER TERMS AND CONDITIONS:

- 10.1. Construction work causes vibration, dust, and movement in other areas of the property. HGE is not responsible for damages to personal property or building that this may cause. Homeowner agrees that HGE is not responsible for cracks or damages to driveway or property due to weight of HGE's trucks or disposal container. Homeowner is to carry fire, tornado, and any other necessary insurance. Homeowner will also be responsible for obtaining any necessary HOA approvals.

 10.2. Finance Charge. In the event of your failure to make payment as provided herein, the outstanding balance shall bear interest at the rate set of one percent (1%) per month until paid in full, or the maximum legal rate under applicable law, whichever is less.
- 10.3. Contracts over \$10,000 will require progress payments. A schedule shall be provided and mutually agreed upon by you and Contractor prior to commencement of work.
- 10.4. HGE will not be held liable for failure of performance due to adverse weather, labor strikes, accidents, fire, flood, explosion, or any other cause or delays beyond its reasonable control. Furthermore, HGE is not liable for any delays caused by the Client. HGE is not responsible for any special, consequential and/or indirect damages or loss of use resulting from its performance even if HGE or its agents have been advised of the possibility of such damages or if a remedy set forth herein is found to have failed its essential purpose.
- 10.5. Client will disclose any knowledge of the presence of hazardous material (as defined by law) known or suspected on the premises. Should any previously undisclosed hazardous materials be disclosed or discovered after this Contract is signed, HGE may, at its sole discretion, terminate this Contract and Client agrees to pay for all labor and materials expended up to the date of cancellation lost overhead and profit, and any the cost of any emergency measures taken by client.

 10.6. In any dispute arising under this Contract (whether based in contract, tort, or both), Client and HGE agree that each party will be responsible for its own attorneys' fees and costs. Moreover, the parties agree that should Client bring any legal
- party will be responsible for its own attorneys' fees and costs. Moreover, the parties agree that should Client bring any legal action against HGE for any cause(s) of action, the maximum damages award available to Client is the amount paid by Client to HGE under this Contract.
- 10.7. If accepted, this Contract constitutes the entire Contract between the parties, and supersedes all prior proposals, contracts, or agreements, oral or written, between the parties relating to the subject matter of this Contract.
- 10.8. HGE advises that there may be changes in the work that are reasonably necessary to accomplish the provisions of this Contract. HGE will notify Client of such changes prior to commencement of such work in the form of a written Change Order. Extra work and Change Orders become part of the contract once the order is prepared in writing and signed by the parties.
- 10.9. HGE reserves the right to withdraw this Contract at any time prior to Client's acceptance without any liability.
- 10.10.Client is entitled to a completely filled in copy of this contract, signed by both Client and HE
- 10.11.HGE maintains \$2,000,000 in general liability insurance

- 11. Washington D.C. Residents: Do not sign a blank contract. Homeowner is entitled to a copy of the contract (including any addenda) at the time he or she signs.
- 11.1. If this agreement was solicited at your residence and you do not want the goods or services, you may cancel this agreement by mailing a notice to the seller. The notice must say that you do not want the goods or services and must be mailed before midnight on the third business day after you signed this Contract. The notice must be mailed to Home Genius Exteriors 1682 Langley Ave Irvine CA 92614. If you cancel the seller may not keep any part of your cash downpayment.
- 12. Maryland Residents. Each Contractor and Subcontractor must be licensed by the Commission and anyone may ask the Commission about a contractor or subcontractor. - 12.1.
