The process includes removing and disposing of the existing roofing material from the above roof areas. *GAF Weather Watch Ice and Water Shield material will be installed around the base of the chimney, in the valleys and three feet along the bottom edges of the roofs. *GAF pro starter shingles will be installed along the eaves of the house. *GAF Tiger Paw synthetic felt and *GAF Timberline HDZ Architectural fiberglass shingles, in a standard color of your choice, will be installed using 1¼ inch roof nails to fasten them. New aluminum drip edge will be installed around the perimeter of the roofs. New copper chimney flashing and standard vent pipe flanges will be installed to replace the existing. Cobra Snow Country ridge vent will be installed on the peak of the dormer roof; 5 new 750 box vents will be installed where needed to properly ventilate the attic. Seal-a-ridge hip and ridge shingles will be installed over the ridges and ridge vents. Debris will be removed from the gutters and downspouts after the new roof is installed.
